County Clerk Jamie Romeo Calls On State Legislature To ‘Fix Tier 6’

(Rochester NY) – Throughout the COVID-19 pandemic, public employees across many sectors became essential workers, including the staff of the Monroe County Clerk’s Office.

According to County Clerk Jamie Romeo “Staffing shortages in the public sector are at crisis levels, from public education to health care, transportation to emergency services. Employers at every level of government have sounded the alarm that they cannot recruit enough staff or encourage qualified individuals to stay in service. Our office is no exception to this. **In order to retain and invest in our staff, along with bolstering recruitment efforts, we must Fix Tier 6.**”

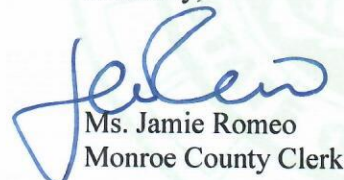
